**Duties and Responsibilities:** Deputy Director (Implementation, Inspection and Monitoring) will function as second Liasion Officer of the Foundation with the State Govts.; looks after State Library Committee (SLC) matters; performs the duties as Supervisory Officer of the Implementation and Inspection and Monitoring Sections in implementing various schemes of the Foundation; conduct inspection with the help of five Field Officers of the grantee institutions; monitors assistance rendered under various schemes; supervises the activities of five Field Officers at five different zones of the country and takes up follow-up action on inspection reports furnished by Field Officers; collects requisite information from the State Governments regarding libraries and library services in the states; performs public relation activities with various organizations and individuals; assists Accounts Officer in the preparation of accounts and budget of the Foundation; to report to the Director General.
