

## **Post-Conference Report**

### **G20 Library Summit**

"Connecting Nations for Knowledge and Cultural Heritage"

Date: February 7–9, 2024

Venue: Pondicherry University, Puducherry, India

The G20 Library Summit 2024, hosted by Pondicherry University, served as a platform for global leaders, librarians, academicians, policymakers, and technology experts to deliberate on the evolving role of libraries in the digital era. This summit, themed "Connecting Nations for Knowledge and Cultural Heritage," aimed to foster collaboration among G20 nations to enhance access to information, promote digital literacy, and strengthen libraries' role in achieving the United Nations Sustainable Development Goals (SDGs).

With over 300 participants, five members each for the Plenary Talk and Panel Discussion, 18 invited speakers, 12 chairs and co-chairs, 13 rapporteurs and co-rapporteurs, 212 paper presenters, and delegates from various countries, the three-day summit featured nine technical sessions with two sub-sessions, a plenary talk, a panel discussion, and inaugural and valedictory sessions.

Discussions focused on key areas such as digital transformation, open access, AI in libraries, literacy promotion, indigenous knowledge preservation, emerging technologies, and sustainable development.

The event commenced with an inaugural session and insightful technical presentations and discussions. Eminent speakers emphasized the growing need for international collaboration in sharing knowledge, digital innovation, and preservation of cultural heritage.

#### **Inaugural Session**

The summit was inaugurated by Prof. K. Tharanikkarasu, Vice-Chancellor (i/c) of Pondicherry University, who emphasized the importance of libraries as pillars of democracy and knowledge dissemination. The keynote address was delivered by Prof. Devika Madalli, Director of INFLIBNET, Ahmedabad, who highlighted the critical role of libraries in bridging the digital divide and preserving cultural heritage. Other dignitaries included Prof. Constantine Matoke Nyamboga, Vice-Chancellor of Lukenya University, Kenya, Prof. Helene Guetat from the University of Toulouse, France, and Mr. Andrei Sokolov, Director of Business Development, Neopolsk, Russia.

## **Summit Sessions Overview**

### **Plenary Talk:**

The Plenary Talk on "G20 Library Summit – Connecting Nations for Knowledge and Cultural Heritage" was held on February 7, 2024, and chaired by Prof. Vaishali Praful Gudadhe from Sant Gadge Baba Amravati University, India. The session featured distinguished speakers, including Prof. Ramesh Chandra Gaur (IGNCA, New Delhi), Dr. Sangeeta Kaul (DELNET, New Delhi), Prof. Constantine Matoke Nyamboga (Lukenya University, Kenya), and Mr. Andrei Sokolov (Neopolsk, Russia).

The discussions emphasized the role of libraries in fostering global knowledge exchange and the importance of international collaboration in leveraging digital technologies to enhance library services. The speakers also highlighted strategies for preserving cultural heritage through library-led initiatives, reinforcing the need for sustainable efforts in documentation and digitization.

### **Technical Sessions Summary**

The G20 Library Summit 2024 featured a series of technical sessions, a plenary talk, and a panel discussion, all aimed at exploring the evolving role of libraries in a rapidly changing digital landscape. The Plenary Talk on "G20 Library Summit: Connecting Nations for Knowledge and Cultural Heritage", chaired by Prof. Vaishali Praful Gudadhe (Sant Gadge Baba Amravati University, India), set the tone for the summit. Distinguished speakers, including Prof. Ramesh Chandra Gaur (IGNCA, New Delhi), Dr. Sangeeta Kaul (DELNET, New Delhi), Prof. Constantine Matoke Nyamboga (Lukenya University, Kenya), and Mr. Andrei Sokolov (Neopolsk, Russia), highlighted the need for international collaboration, knowledge sharing, and digital innovations to strengthen global library systems.

The technical sessions covered a diverse range of topics. Session I on Global Information Access focused on digital libraries, open educational resources, AI in libraries, and research ethics, with 11 papers presented. Session II explored Preserving Indigenous Knowledge and Languages, discussing digitization strategies, cultural preservation, and manuscript conservation, with 10 papers presented. The Digital Transformation of Libraries was addressed in Session III, split into two sub-sessions (III-A and III-B), featuring AI-driven services, automation, augmented reality, and digital repositories through 16 research presentations. Session IV, Public Libraries as Cultural Heritage Preservation and Access Centers, emphasized disaster management, indigenous heritage, and archival best practices, with eight papers presented.

The role of libraries in international collaboration and policy advocacy was examined in Session V, where eight papers addressed AI adoption, research trends, and policy frameworks. Session VI, Promoting Literacy and Lifelong Learning, split into two sub-sessions (VI-A and VI-B), showcased 20 papers on inclusive education, digital literacy, and lifelong learning initiatives. Session VII, Libraries as Catalysts for Sustainable Development, explored sustainability, environmental awareness, and women's empowerment, with nine papers presented. Session VIII, Future of Libraries in a Changing Digital World, delved into emerging technologies, digital privacy, and user engagement strategies, with nine papers contributing insights into the evolving role of libraries. The final Session IX, Emerging Technology and Trends for Transformation of Libraries, explored AI applications, e-learning tools, social media, and drone technology, with 12 papers presented. Discussions highlighted digital libraries in e-learning, AI's impact on academic libraries, and innovative tech-driven library services.

The Panel Discussion, led by Prof. Pandurang Konnur (LIS Academy, Bangalore), emphasized collaborative efforts in knowledge sharing and cultural heritage preservation. Experts from India and abroad participated in a meaningful dialogue on global partnerships and the future of library networks in fostering access to information and cultural documentation.

### **Key Outcomes & Recommendations:**

1. G20 Digital Library Network – Proposal for a global resource-sharing network.
2. Open Access & Digital Inclusion – Advocacy for free and inclusive digital resources.
3. Capacity Building – Training in AI, machine learning, and digital libraries.
4. Library Infrastructure – Increased funding and modernization initiatives.
5. Sustainability Practices – Green library initiatives and SDG contributions.
6. Preservation of Indigenous Knowledge – Digitization and community collaboration.
7. Literacy & Lifelong Learning – Inclusive education programs for marginalized communities.
8. International Collaboration – Addressing misinformation, digital privacy, and access.
9. Emerging Technologies – Adopt AI, AR, and drones in library services.
1. User-Centric Services – Personalizing library experiences using data analytics.

The valedictory session, presided over by Prof. Ajay Pratap Singh (Director General, National Library of India), highlighted the summit's impact on shaping the future of libraries. The event successfully fostered global partnerships and innovation, reinforcing the role of libraries in advancing knowledge, culture, and sustainability.

Pondicherry University was pivotal in hosting this landmark summit, leaving a lasting impression on the global library community.
